FRIDAY MORNING DEPART FROM HOTEL 9:00 AM SHARP - LUNCH WILL BE PROVIDED (BBQ BURGERS, DOGS, SNACKS, WATER AND GATORADE), IF YOU DESIRE SOMETHING OTHER THAN BBQ YOU WILL NEED TO BRING YOUR OWN RATIONS.

GOOD BAJA BIKES ONLY, FOUR STROKES PREFERRED, GOOD TIRES WITH BRIDGESTONE ULTRA DUTY TUBES, CARRY THE TOOLS, MONEY, WATER, & SNACKS YOU MIGHT NEED. THE CHASE TRUCK WILL HAVE MINIMAL TOOLS. EACH RIDER WILL NEED TO BRING A FULL FIVE GALLON GAS CAN TO PUT IN THE CHASE TRUCK. GET MEXICAN INSURANCE ON YOUR VEHICLE, AND BRING YOUR PASSPORT, TRUCK & MOTORCYCLE REGISTRATION. THE CHASE TRUCK WILL TRANSPORT YOUR BAG & GAS AND WILL REFILL YOUR GAS CAN AS NECESSARY FOR THE RIDE.
